

# KEYNOTE ADDRESS



## **TAN SRI MOHD DUSUKI BIN MOKHTAR** Attorney General of Malaysia

Tan Sri Mohd Dusuki bin Mokhtar was born on 6 March 1967 in Machang, Kelantan. He holds a Bachelor of Laws (LL.B. Hons) degree from the International Islamic University Malaysia (IIUM), which he obtained in 1992, and a Master of Laws (LL.M) degree from the University of Wollongong, Australia, completed in 2012 with a specialisation in Prosecutorial Practice. Dato' Mohd Dusuki began his legal career in 1993 as a Deputy Public Prosecutor in the Prosecution Division of the Attorney General's Chambers. Over the span of more than three decades, he has served in various key positions across Kelantan, Perak, and the headquarters of the Attorney General's Chambers in Putrajaya. Among the prominent roles he has held are Federal Counsel at the Ministry of Home Affairs, Chairman of the Industrial Court under the Ministry of Human Resources, Head of the Appeals Unit, and Head of the General and Sexual Crimes Unit cum Director of the National Revenue Recovery Enforcement Team (NRRET). He also served as Deputy Head and later Head of the Appellate & Trial Division of the Attorney General's Chambers. On 12th November 2024, Dato' Mohd Dusuki was appointed as the 13th Attorney General of Malaysia, thereby making him the Head of Service for Judicial and Legal Officers. In recognition of his distinguished service in the public sector, Dato' Mohd Dusuki has been conferred several honours, including the Ahli Setia Mahkota Kelantan (ASK) in 2000, the Darjah Dato' Paduka Seri Kelantan (DPSK) which carries the title Dato' in 2016, and the Johan Setia Mahkota (JSM) by His Majesty the Yang di-Pertuan Agong in the same year.

# KEYNOTE ADDRESS



## **JUSTICE DATO' LIM CHONG FONG** Court of Appeal Judge of Malaysia

The Honourable Justice Dato' Lim Chong Fong currently serves as a Judge of the Court of Appeal of Malaysia. He is widely recognised as one of the nation's foremost authorities in construction law, arbitration, and statutory adjudication. Justice Lim's career began in the construction industry as quantity surveyor in Singapore, before transitioning into legal practice. He was called to the Malaysian Bar in 1991 and subsequently to the Bar of England and Wales in 1995 (Middle Temple). He also holds admission to the Brunei Bar. Justice Lim holds a Bachelor of Science (Hons) in Building from the National University of Singapore, a Bachelor of Laws (LL.B Hons) from the University of London, a Master of Laws (LL.M.) from the University of Malaya, and the Certificate in Legal Practice (CLP) from Malaysia. He is also a Chartered Quantity Surveyor and a Barrister-at-Law (Middle Temple), having formerly practiced as a Chartered Arbitrator, contributing significantly to the field of alternative dispute resolution. Justice Lim presently acts as the Chairman of the Court Annexed Mediation Committee of the Malaysian Judiciary. Prior to his elevation to the Bench, Justice Lim was a partner at the law firm Azman, Davidson & Co, where he specialised in construction and infrastructure disputes. His deep understanding of the construction industry, both from technical and legal perspectives, led to his active involvement in the drafting and implementation of the Construction Industry Payment and Adjudication Act 2012 (CIPAA). In addition to his judicial and professional contributions, Justice Lim is a well-regarded author and academic contributor. He is co-author of the seminal legal text "Adjudication of Construction Payment Disputes in Malaysia", a key reference in Malaysian construction law practice. Justice Lim's distinguished career and his pioneering work in statutory adjudication continue to shape the legal landscape of dispute resolution in Malaysia and beyond.

Julian is a visiting professor at the Dickson Poon School of Law, King's College, London and is an adjunct professor of law at Hamad bin Khalifa University, Doha, Qatar.

Federal Court Judge of Malaysia

Justice Dato' Lee Swee Seng graduated with a Bachelor of Laws (Hons) degree from University of Malaya and obtained his Master of Laws from the same university. He also holds a MBA degree from University of Southern Cross, Australia. Justice Dato' Lee was called to the High Court of Malaya in February 1985 and was in active legal practice until May 2010 when he was appointed a Judicial Commissioner of the High Court of Malaya. He was made a Judge of the High Court of Malaya in 2014 and elevated to the Court of Appeal on 8 August 2019 and recently to the Federal Court on 20 May 2025. Prior to his elevation to the Federal Court, Justice Dato' Lee sat in the Commercial and Civil Divisions of the High Court in Kuala Lumpur and also presided in the specialist Construction Court in the High Court at Kuala Lumpur from 2016 to August 2019 where he heard construction cases as well as those involving enforcement and setting aside of arbitral awards as well as adjudication decisions. He was involved in the early exposition of the law of construction adjudication through his many decisions on cases that came before the Construction Court since the implementation of the Construction Industry Payment and Adjudication Act 2012 that came into force on 15 April 2014. He was also the Chair of the Construction Panel of the Court of Appeal before his elevation to the Federal Court. Justice Dato' Lee was a visiting Fellow of Taylor University Law School and a part-time lecturer with the Law Faculty of his Alma Mater for the LLM Masters Programme. He is also an Elite Fellow with the Law Faculty of University of Malaya. Justice Dato' Lee is a trained advocacy trainer with Bar Council Malaysia and is a certified mediator with the Malaysian Mediation Centre before joining the Bench. He also achieved the highest award in the Toastmasters International as a Distinguished Toastmaster. Justice Dato' Lee was the General Editor of the Law and Practice of Family Law in Malaysia published by Sweet & Maxwell in 2019 and currently a committee member of the Court-Annexed Mediation Committee of the Malaysian Judiciary.





**PROFESSOR TERESA CHENG GBM GBS SC JP**

Chartered Arbitrator, Former Secretary for Justice of the Hong Kong SAR

Ms. Teresa Cheng, Senior Counsel, is an arbitrator, mediator and chartered civil engineer. She is currently an Adjunct Professor of Tsinghua University and Course Director of International Arbitration and Dispute Settlement Program. She was one of the founders of the Asian Academy of International Law and in 2017, as the founding Chairman of AAIL, she signed the Memorandum of Understanding with CAERP (China-AALCO Exchange and Research Platform) to cooperate in the area of international law research and training and in particular to host part of the CAERP training for AALCO (Asian African Legal Consultative Organization) delegates in Hong Kong. She is currently a co-chairman of AAIL. She was a member of the World Bank's International Centre for Settlement of Investment Disputes (ICSID) Panel of Arbitrators, designated as an ICSID arbitrator by the Chairman of the ICSID Administrative Council in 2011 and by China in 2017. She has acted as counsel and sat as arbitrator in international investment disputes and also rendered decisions as member of ad hoc committees dealing with application for annulment of ICSID awards. She also served as Deputy Judge/Recorder in the Court of First Instance of the High Court of Hong Kong SAR from 2011 to 2017.


**RATAN K. SINGH**




